Additional affiliation was granted to B.A English Language & Literature(24), B.A Economics(40) and B.Com Co-operation(40) in the academic year 2017-18 with permission to start classes in 2018-19, vide University Orders read as (2) and (3) above. Additional affiliation was granted to B.Sc Chemistry (24) in the academic year 2019-20 vide University Order read as (4) and (5) above. Additional affiliation was granted to B.Sc Physics (24) and M.Com Finance (15) programmes in the academic year 2020-21 vide University Orders read as (6) and (7) above respectively. Continuation of provisional affiliation was granted to the above programmes for the academic year 2021-22, vide University Orders read as (8) and (9) above.

6 . **Affiliation granted is strictly provisional and only for the academic year 2022-23. Conditional affiliation, granted, shall be confirmed only after producing renewal NOC for the academic year 2022-23 from the Government.** The College has to apply for continuation of provisional affiliation for the ensuing academic years by remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University.



The management should abide by the provisions of the University Act, Statute and Regulations with regard to admission of students, collection of fee etc. Selection and admission shall be made only on the basis of the rules and regulations of the University/ Government and on the basis of the directions issued by the University/ Government from time to time, failing which the affiliation granted will automatically be cancelled.

8. The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.

9. The Principal shall strictly follow the syllabi approved, which is available in the University website ([www.uoc.ac.in](http://www.uoc.ac.in)) for selecting complementary courses.

10. The Controller of Examinations shall ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.

11. In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the Institution shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent such instances, stringent action including withdrawal of affiliation of the College will be initiated.


